Acknowledgment of Risk and Waiver of Liability

This is a legally binding agreement. By signing for yourself, you give up the right to bring a court action to recover compensation or any other remedy for injuries or death to yourself, or to your property, arising out of the CONSTRUCTION COMBINE (herein "Activity") sponsored by The Spokane Home Builders' Association to be held at Home Depot, Liberty Lake, WA April 23 and 24th, 2020. Read this Acknowledgment of Risk and Waiver of Liability carefully and in its entirety. It is a binding legal document.

I, (meaning an adult participant for him/herself), understand and acknowledge that participating in the Activity sponsored by Spokane Home Builders Association (herein "SHBA") entails inherent, known, and unanticipated risks which are voluntarily assumed. These risks include, but are not limited to, training that involves framing, concrete, electrical, plumbing, flooring, and masonry, that may cause slips and falls, sprains, strains, broken bones, cuts, abrasions, burns, broken bones, concussions, internal injuries, failure or misuse of equipment, human carelessness, error, and misjudgment; and other injuries which could occur and result in emotional or physical injury, paralysis, death, or damage to property or third parties. By participating, I certify that I have full knowledge of and voluntarily assume all risks, that participant (myself or my minor child) is in good health and has no physical or mental limitations that would preclude the safe participation in this Activity.

Release/Indemnification/Covenant Not to Sue

To the fullest extent permitted by law, and in consideration for my participation in this Activity, on behalf of myself, my heirs, representatives, executors, administrators, and assigns (the Releasing Parties) hereby agree to indemnify, defend, save, hold harmless, release and covenant not to sue the State of Washington, its State Board of Education, the Spokane Home Builders Association, its members, respective officers, employees, volunteers and agents (the Released Parties) for any negligently caused injuries or losses arising from or related to the Activity. I further agree to defend and indemnify the Released Parties and each of them from any claims, demands, actions, damages, costs, fees or expenses arising out of losses suffered by or caused by me or my minor child that are brought now or in the future by the Releasing Parties or any of the m, or by a third party.

On behalf of myself, I hereby consent to emergency medical care, including transportation to and exchange of medical information with a medical facility. I understand that I am responsible for all medical expenses for me in this high risk Activity, as well as the cost of any necessary rescue or evacuation. I grant SHBA the right to use for promotional purposes, any photographs or video footage taken of me during the Activity. This agreement and any claims arising out of or relating to this agreement shall be governed exclusively by the laws of Idaho. Jurisdiction and venue for all disputes, claims, and/or legal actions shall be the Superior Court for Spokane County, Washington, exclusively. This agreement shall be governed by, and construed in accordance with, the internal domestic laws of the State of Washington, without reference to choice of law principles.

If I am executing this document as a parent/guardian of a minor child, I represent and warrant that I have read the terms and agree to them, and have the legal right to execute this document on behalf of the minor, and that this document, once executed by me, is fully enforceable in accordance with its terms. I agree to indemnify the Released Parties in the event the representation is not accurate.
